## Bag/Possession Limits

### **Mourning & White-winged Dove**

15 Dove with 10 of which may be White-winged Dove in total within the Daily Bag Limit.

Possession Limit is triple the Daily Bag Limit.

### **Spotted Dove, Ringed Turtle Dove, & Eurasian Collared Dove**

**No Bag or Possession Limit**

### **Gambel's Quail**

10 Quail within the Daily Bag Limit.

Possession Limit is triple the Daily Bag Limit.

## **Rules & Regulations**

### **Entry Permit**

I understand that permission for me to enter the Chemehuevi Tribal Lands is conditioned on my observance of tribal laws and regulations and that any violations of such makes me a trespasser and subject me to Tribal, State or Federal Court Action, expulsion from tribal lands, and possible seizure of property as security for potential obligations to the Tribe.

### **Jurisdiction**

Except as otherwise provided by the Conservation Code or Federal Law, the Chemehuevi Indian Tribe, through its Tribal Council, Conservation Management and such other Tribal Entities as are designated by Tribal Law, shall have absolute original jurisdiction to regulate and adjudicate all matters pertaining to Wildlife found on or within tribal lands, whether resident or migratory, native or introduced, and all matters pertaining to the recreation and other natural resources of the Chemehuevi Tribal Lands. The Chemehuevi Conservation Department has been delegated the authority and responsibility of enforcing regulations on the Chemehuevi Tribal Lands under the Chemehuevi Conservation Code and USC, Title 18, Sections 1163, 1164, 1165, and the Lacey Act.

### **Enforcement**

All Conservation Officers have the authority and duty to enforce all laws and regulations of the Tribe, relating to Conservation and/or the management of the wildlife, recreation, or other natural resources of the Chemehuevi Indian Tribe. Amendments of 1981, Public Law 97-79.

### **Lawful Means of Taking Upland Game**

Shotguns 12 gauge or smaller using shot shells only and incapable of holding more than three shells in the magazine and chamber combined may be used. If a plug is used to reduce the capacity of a magazine to fulfill the requirements of this section, the plug must be of one-piece construction incapable of removal without disassembling the gun. Shotgun shells may not be used or possessed that contain shot size larger than No. BB or T shot in steel or other nontoxic shot approved by the U.S. Fish and Wildlife Service. All shot shall be loose in the shell. No BB Guns allowed during hunt.

### **Youth Hunting**

All youth hunters 16 years of age and younger must have a youth upland hunting permit and be accompanied by an adult during the hunt.

### **Shooting Hours**

The shooting hours for all upland game birds shall be from one-half hour before sunrise to sunset.

### **Spinner/Motion Style Decoys**

The use of spinning wing/motion decoys are permitted with a maximum of two per person.

### **One Feathered Wing**

Sportsmen should note that one feathered wing must be left attached to all upland game birds until they reach their destination.

### **Live Decoy Prohibition**

The use of live decoys is prohibited when attempting to take migratory game birds.

### **Use of Dogs**

Dogs may be used to take and retrieve migratory game birds.

**OPEN AND CLOSED HUNTING ZONES**



**Open Hunting Zone**

Hunting Upland birds is permitted only within the designated area of hunting, within the Chemehuevi Indian Tribe Reservation i.e. South of The Havasu Landing Resort.

**Closed Hunting Zone**

North section of the Reservation, starting from the North rim of Chemehuevi Wash. California Hunting License is Required when taking Upland birds West of the Tribal Hunting Zone.
